Civic Association calls for letters for setting up a Restoration Advisory Board for Buxton

The Buxton Civic Association is calling for the setting up a Restoration Advisory Board for the old Buxton Navy Base property.

The association drafted a letter to be sent to various regulatory and legislative representatives asking for a speed up in the set up. The drafted letter is intended for guidance for others to send to the extensive list of representatives.

The letter states "The lack of transparency from the Army Corps of Engineers, the Coast Guard, and the National Park Service regarding these issues is unacceptable. The community is entitled to full disclosure and regular updates on the measures being undertaken to address these serious problems.

"Considering these significant concerns, I respectfully request the immediate establishment of a Restoration Advisory Board (RAB) program. This initiative will facilitate enhanced communication and collaboration between the responsible agencies and the affected community, ensuring that cleanup efforts are prioritized and effectively managed. Further, I implore all involved agencies to cease the decades-long practice of finger-pointing, blame-shifting, and compartmentalization of the areas and, instead, work together for a comprehensive solution." Rodanthe channel shoaled

The Dare County Waterways Commission learned Monday, that an area in the federal channel into the Rodanthe Harbor is shoaled and would not be available for an emergency ferry route. The Army Corps of Engineers is responsible for the Rodanthe ferry channel but the Corps does not have a project planned for the Rodanthe Harbor.

The shoaled area measures about five feet deep. Ferries need five and half feet. The authorized depth is six feet.

Dare County has repaired the area for dredged material which is alongside the harbor.

New recreational, commercial harvest reporting requirements delayed to December 1, 2025

New harvest reporting requirements for recreational and commercial fisheries have been delayed by one year and will now become effective on December 1, 2025.

The N.C. General Assembly recently passed Session Law 2024-45, which, in part, amends legislation from last fall that would have implemented the harvest reporting requirements on December 1, 2024.

This extension will allow the North Carolina Division of Marine Fisheries and the state's Wildlife Resources Commission to engage with stakeholders, not only to inform them about the requirements, but also to ensure that the reporting process and tool(s) are robust and user-friendly.

The legislation from last fall requires that any person who recreationally harvests Red Drum, flounder, Spotted Seatrout (speckled trout), Striped Bass and Weakfish (gray trout) must report that harvest to marine fisheries. This requirement applies to fish harvested from coastal fishing waters, joint fishing waters and inland fishing waters adjacent to coastal or joint fishing waters. Additionally, the law requires anyone holding a commercial fishing license who is engaged in a commercial fishing operation to report all fish harvested to marine fisheries, regardless of sale. Drought strikes North Carolina

For the first time in 15 years, the entire state of North Carolina is either "abnormally dry" or in a drought.

Drought conditions continue to worsen across North Carolina this week, with nearly 90% of the state now facing moderate, severe or extreme drought, reports the Drought Management Advisory Council.

While rain has come in eastern and central North Carolina, it is too late. North Carolina is already seeing widespread crop losses. Some 40% of corn crops are in very poor condition. This is just the second time in 24 years the state has seen such a rapid deterioration of drought conditions, the Department of Environmental Quality said. In late June, more than 50% of North Carolina was increased to a more severe status in just one week.

While rain in the last week slowed the rapid drying, it wasn't enough to improve conditions in some places.

Dare County remains in moderate drought.

Drug arrest day before July 4

On July 3, 2024, at approximately 10:56 at night, the Dare County Sheriff's Office C-District conducted a traffic stop on a vehicle near Kinnakeet Blvd on NC 12 in Avon. During the stop probable cause was established to conduct a search of the vehicle.

During the search of the vehicle an amount of Fentanyl, Heroin and Drug Paraphernalia were located and seized. The investigation continued to a hotel room where the individual was staying and an amount of Cocaine, Marijuana, Prescription Medication and more Drug Paraphernalia were located and seized.

William Thaddeus Bridgeman, 45, Reston, Virginia, was charged with two counts of felony Possession of Schedule I, felony Possession of Schedule II, Possession of Drug Paraphernalia and misdemeanor Maintaining a Dwelling. Bridgeman was issued a \$50,000 secured bond.

North Carolina Celebrates More Than 500,000 Enrolled in Medicaid Expansion

More than half a million North Carolinians have now enrolled in Medicaid expansion since the program began seven months ago. Beneficiaries are now able get quality health care they need. People can see a doctor, get preventative care, manage chronic conditions and get life-saving prescriptions without the burden of high premiums or co-pays.

Since December 1, 2023, new Medicaid enrollees have filled more than 1.9 million new prescriptions for conditions like heart health, diabetes, seizures and other illnesses. Medicaid has also covered more than \$28.6 million in claims for dental services since expansion began. Currently, 503,967 North Carolinians have enrolled in Medicaid expansion, something that was expected to take two years.

People who did not qualify for Medicaid in the past may now be eligible, including those who are single, have higher incomes, and don't have children or a disability. The North Carolina Department of Health and Human Services Medicaid Expansion website provides information on eligibility, how to apply and where to find support. Individuals can also connect with state and local support teams to better understand their health care coverage options, complete Medicaid applications and navigate the enrollment process, as well as for help with language translation services.

The 15th annual North Carolina Beach Buggy Association Red Drum Tournament is scheduled for October 23 to October 26, 2024, and tournament organizers are urging anglers to sign up now. A cap of 500 anglers is in place this event

The 2023 NCBBA Tournament featured a record 455 anglers, with 120 red drum caught and released.

In celebration of the 150th anniversary of the Life-Saving Service, Jen Carlson is providing snippets of maritime history, titled All in a Day's Work.

Sometimes it's just about patience: Just before daybreak on December 27, 1895, Keeper Little Bannister Midgett, Jr. was in the lookout stand and spotted a schooner about 3 ½ miles south of the Chicamacomico LifeSaving Station. Moments later a signal was spotted from the schooner indicating help was requested. Immediately, Keeper Midgett lead his crew into the early morning hours. Upon arriving on scene, it was discovered that there was nothing that could be done to assist as the crew of the Lou Willis actually landed themselves onshore before the Chicamacomico crew arrived and the tide going out had left the schooner high and dry. It was going to take skids to get the vessel off the sandbar. Nearly a month later, the vessel's master requested help once again as the skids were now acquired and he needed assistance in launching the schooner. He was very appreciative of the work the surfmen did to help him relaunch his vessel.
